FORT LAUDERDALE, Fla.: Lottery experts will examine the future of the lottery and its customer base at the National Council of Legislators from Gaming States (NCLGS) 2024 Winter Meeting at the Hilton Fort Lauderdale Marina, January 3-6.

NCLGS neither promotes nor opposes gaming but is focused on proper regulation and promoting best practices in the governance of this important industry.
